4. FIRST AID MEASURES

Suitable and unsuitable extinguishing media: None required.

Specific hazards arising from the chemical: Closed containers may explode from internal pressure build-up when exposed to extreme heat and discharge contents. Liquid content of container will not support combustion. Overexposure to

decomposition products may cause a health hazard. Symptoms may not be readily apparent. Obtain medical attention. Hazardous decomposition products include carbon dioxide, carbon monoxide, and other toxic fumes.

Special equipment and precautions for fire-fighters: Water may be used to cool containers to prevent pressure build-up and explosion when exposed to extreme heat. Wear goggles and use self-contained breathing apparatus. If water is used, fog nozzles are preferred.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment, and emergency procedures: Avoid breathing vapors. Ventilate area. Remove all sources of ignition.

Methods and materials for containment and cleaning up: Clean up with absorbent material and place in closed containers for disposal.

Precautions for safe handling: Keep closure tight and container upright to prevent leakage. Open container slowly. Do not get in eyes. Avoid skin contact and contact with clothing. Do not take internally.

Conditions for safe storage, including any incompatibilities: Store and use in cool, dry, well-ventilated areas. Keep containers closed when not in use. Keep away from excessive heat or open flame.
